GENERAL INFORMATION:

Competitors are required to pay a non-refundable \$10.00 hook fee per tractor for each weight class entered.

Weigh in time starts at 8:00 AM and will end at 10:30 AM.

Eligibility: Antique Tractors must be a **1970 or older model**. Sorry, no exceptions.

Tractor tires must be no wider than 18.4" to compete.

Larger tires will be allowed to pull for exhibition only, hook fee is still required.

ANTIQUÉ TRACTOR PULL
3 WEIGHT CLASSES:

0 – 3,500 lbs.

3,501 – 5,000 lbs.

5,001 –7,500 lbs.

Any situation that may arise and is not covered by the rules will be decided upon and left to the discretion of the Judge's Committee. The decision of the judges is final.

Rochester Country Fair Antique Tractor Pull 2010 RULES AND PRIZES

**New Rule* – Tires will be no wider than 18.4” to compete.

Larger Tires will be allowed to pull for exhibition only. Hook fee is still required.

Exhibition class does not compete for prizes.

1.) A pair of wheelie bars having flat, rigid steel pads at least 4 inches square are **required** with the pads located as follows:

- Tractors with 24-inch or smaller rear wheels shall have pads located with the rear edge no higher than 7 inches from a flat, hard surface.
- For 26 through 32” rear wheels, the rear edge of the pad shall be no higher than 8”.
- For 34-inch and larger rear wheels, the rear edge shall be no higher than 10 inches.
- The pads in all cases shall project at least 3 ½ inches beyond the tread surface of the tire measured along a wheel radius and shall be parallel to the ground or angled downward at the front no more than 20 degrees. The supporting structure shall be rigid and sufficiently strong so to withstand jacking the rear wheel of the tractor off the ground.
- Drawbar height should be no more than 20 inches off of the ground.

2.) All hydraulic drawbars will be fixed and no drawbars may be chained in any way or manner. All loose, swinging or excessively worn drawbars will be disqualified.

3.) Length of pull will be 200 feet.

4.) All weights must be secure (no loose weights) and may not exceed two feet in front of tractor (judge’s discretion).

5.) No leakage of fluids will be allowed.

6.) Nitrous Oxide will not be allowed.

7.) Boundaries will be provided on edge of track. A tractor that crosses or touches boundaries will be disqualified.

8.) A. Breakdown before first try, he goes last.
B. After second breakdown the driver is out.
